# Minutes, Finances, and Marketing

<u>Minutes:</u> The Board unanimously accepted the draft Board of Directors' Minutes for the December 12, 2022, Board meeting, without amendments.

<u>Financial report</u>. Treasurer Larry Widmayer reported that:

There was a net return of \$1,335 to the Chamber after expenses, including advertising in the Enterprise, posters/yardsigns/sign boards, Raquel's graphics/social media posts, kids' favors for Santa at the M22 Store, Funistrada gift certificate for Santa & Mrs. Claus, and Township Hall cleaning after the event.

The Financial Report was unanimously accepted without amendment.

There are 24 membership renewals outstanding, and reminders need to be sent through new Treasurer.

# **Leadership discussion**

- Treasurer: Dotti Thompson, Grandpa's Place (to an unexpired 2 year officer term to Fall 2023)
- Assistant Treasurer: Nancy Miller, Devette & Ford Insurance
- Additional Board Director (as provided in by laws for a three year term to Fall 2025): Rebecca Benedict (Cherry Republic)

(Note: The Chamber Board consists of 3 officers elected for 2 year terms and up to 7 directors filling three year terms. The new Bylaws – attached -- required that at least two directors be elected/reelected at each annual meeting)

- Mara requested that Patricia send her the past year of minutes for her review and files
- Dotti reports that she has passed on the Holiday Marketplace chair assignment to Che Woodard (Forest Gallery)
- Mara inquired about the designation of a Parade Marshall for the 4<sup>th</sup> of July Parade. Township Supervisor Tom Laureto and Township Clerk Pam Laureto have taken that responsibility, and should be contacted directly.

# Marketing report

- Raquel reported online presence continues to grow each year:
  - a. Sent a record number of 45 email campaigns between Jan-Dec 2022, with an opening average of 53% (which is exceptionally high);
  - b. An individual post to the Facebook page reaches an average of IK people, organically;
  - c. 3,936 people LIKE the Chamber's Facebook page, and 4,453 people follow the page (up from 3,569 in 2021); total Facebook page visits reached 35,248 people in 2022;
  - d. @visitglenarbor.com now has 2,755 followers on Instagram, with increased followers on Twitter, too.

- e. Visitglenarbor.com has a total of 56899 users, with 88% being "new" users, vs. 11% returning users;
- f. Top referrals to the visitglenarbor.com website are leelanauticker.com, glenarborsun.com, mailchimp email campaign links, leelanau.com, Michigan.org, and traversecity.com.
- g. The average time spent per page by users is 1 minute, 16 seconds.
- <u>Chili Cookoff, Saturday, February 18th</u>: Stephanie at Boondocks confirmed that they will host again for Presidents' Weekend, Saturday, February 18th, pending confirmation of sufficient participants. Set up is anticipated at 11:00 and event at 1:00.

Raquel will offer Chamber marketing support, as before, including e-mail blasts, add to Chamber calendar, and share on social media. But no funds flow through the Chamber.

### **Events Committee Status Reports**

Sue Rife with Glen Lake Manor has offered to host one of the Chamber Connect meetings in 2023.

- b. Raquel will create an online form for sponsorship, which means featuring in ads and website.
- "Season Opener" promotion: Friday, May 19th Sunday, May 21st (Kaitlyn)
- a. Participants must have 6 stamps on "passport" from participating businesses and then turn in passport to ????. Passports will be printed and made available at ????
- b. First prize in the drawing will be \$100 in GA Bucks and second prize in the drawing will be \$75 in GA Bucks. The businesses must turn in the GA Bucks to the Chamber Treasurer for reimbursement.
